How does IBAT work?

At its core, IBAT is a central database for globally recognized biodiversity information including Key Biodiversity Areas and Legally Protected Areas. Through an interactive mapping tool, decision-makers are able to easily access and use this up-to-date information to identify biodiversity risks and opportunities within a project boundary. Exportable maps make it easy for users to quickly share biodiversity assessment results, while downloadable data sets enable your business to conduct additional in-house analysis.

How will a subscription to IBAT benefit my business?

IBAT helps to streamline the project screening process and makes it easier to consider project alternatives at a time when such changes are still economically viable. During subsequent steps of the project life cycle, IBAT can also help to inform the research and baseline studies needed to effectively avoid, minimize and offset potential impacts.
