BirdLife International at the 12th Conference of the Parties to the Convention on Biological Diversity Pyeongchang, Republic of Korea, 6-17 October 2014

ADVOCACY AND COMMUNICATION PLAN SUMMARY

Background

The importance of this 12th Conference of the Parties to the Convention of Biological Diversity (CBD COP12) lies mainly on the mid-way review of progress towards the Aichi Biodiversity Targets since adoption of the Strategic Plan for Biodiversity 2011-2020. At COP12, Parties will be presented with the Global Biodiversity Outlook 4, a flagship publication of the Convention, which will bring information on the level of implementation of each Target and suggested key actions that should ensure progress in implementation of the Strategic Plan. (GBO4 will be launched by the Exec. Sec. on the first day of the COP).

Since the adoption of the Strategic Plan for Biodiversity 2011-2020, the Convention is investing efforts in guiding Parties towards stronger implementation and in streamlining its processes, looking at a more effective Convention operation. Therefore, no major new commitment is expected at this COP. The content of negotiations on various topics will be a follow up and/or further development of previous agreements.

BirdLife objectives

To promote BirdLife's work on key aspects of biodiversity conservation, demonstrating the clear value and contribution of our data, policy expertise, Partnership support to governments, and conservation achievements – linked to key agenda items being discussed at the COP. This will be demonstrated through:

- o Birdlife's contribution to Global Biodiversity Outlook 4
- 15 side events which BirdLife and the Partnership are leading/presenting
- o Reception on data and decision support tools produced by BirdLife

To influence outcomes – both in terms of strengthening text decisions and ensuring existing text is not weakened. We will focus on the draft resolutions concerning:

- The mobilisation of financial resources for biodiversity
- Marine areas important for biodiversity
- Ecosystem restoration (particularly wetlands and forests)
- o Updating and implementing National Biodiversity Strategies and Action Plans
- Climate change mitigation and adaptation

- Resource Mobilization, a joint position by BirdLife International, Conservation International, The Nature Conservancy and WWF

- A 'health check' position covering: biodiversity and sustainable development, ecosystem restoration, invasive alien species, climate change, progress in updating and implementing NBSAPs, cooperation with other Conventions, business and biodiversity and milestones for Aichi Target 3.
